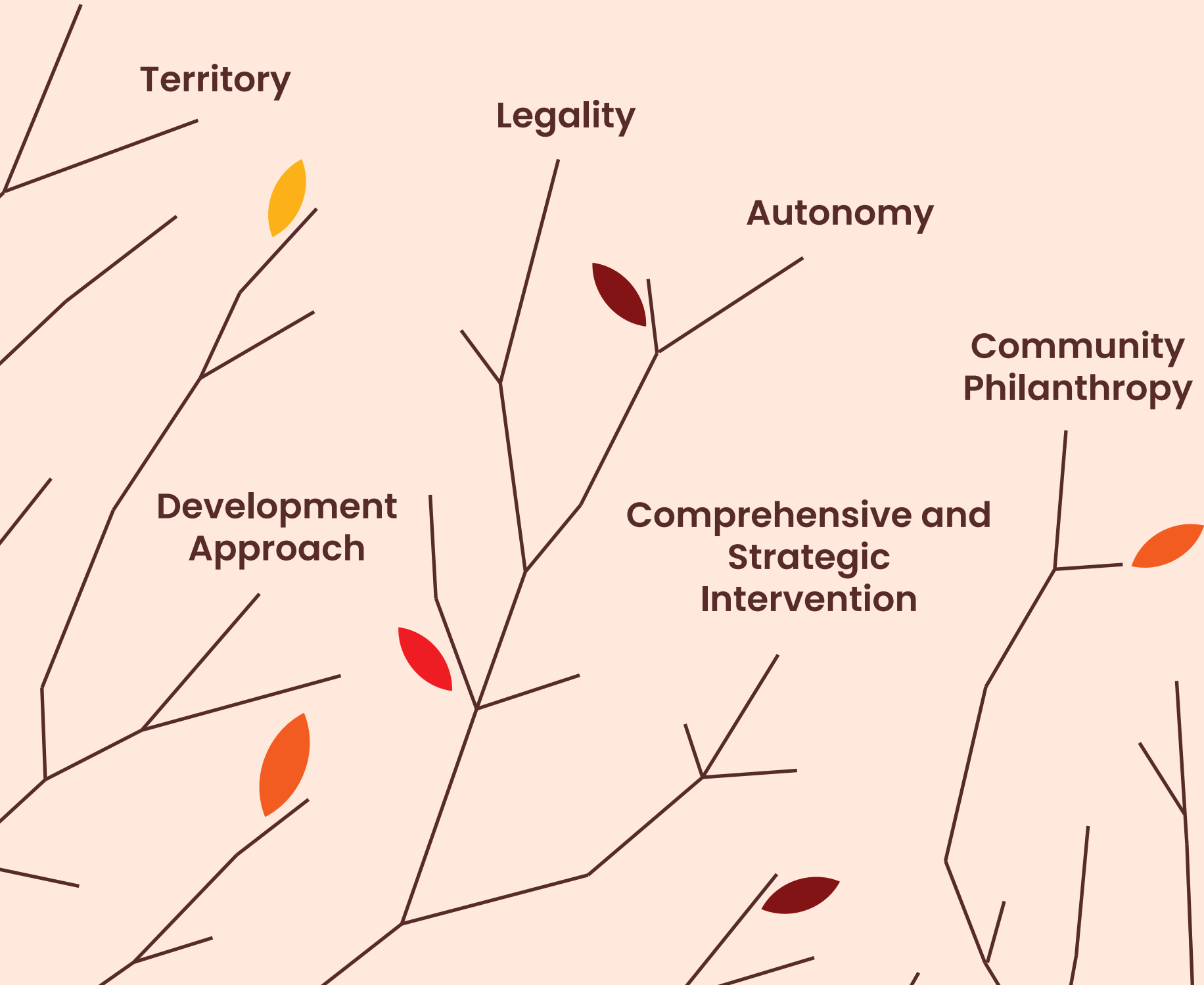

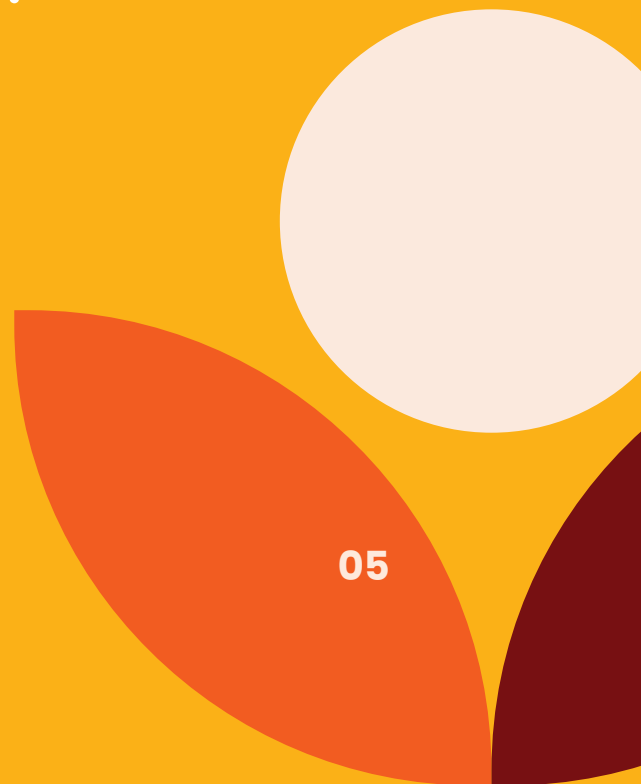

This process made it possible to gather shared indicators and consolidate them into data that highlights the collective impact of the community foundation movement within Mexico's social sector.

Impact of community foundations



The Alliance of Community Foundations of Mexico is made up of **16 community foundations**, with the participation of **169 board members**, **314 staff members**, and **568 volunteers**.

We also strengthened the communication of our value proposition in capacity building for community foundations:



Collective strengthening

Comunalia firmly believes in the importance and effectiveness of peer learning as a strategy to strengthen its members.

Communities of Practice: A trusted space where experiences are shared to address areas of opportunity, and tools are introduced to foster mutual understanding and create a peer support system.

Learning Exchanges (Internships): Resources that enable community foundations to visit one another in person, immerse themselves, and learn directly from the programs and strengths of their fellow organizations.



Individual Strengthening

Through these programs, we offer community foundations the opportunity to request support to address specific needs identified in their strengthening roadmap developed with Comunalia.

Personalized Technical Assistance: Resources to invest in consulting, advisory services, mentoring, and other support tailored to their specific needs.

Scholarships: Funding to attend training sessions, courses, conferences, and other relevant events that contribute to their work.

Vital Signs: A program that uses local data and participatory processes to identify the needs and priorities of communities.



Communication and Connections within the Community Foundation Movement

Comunalia HUB A central space where Comunalia shares not only its internal programs and tools, but also facilitates access to external capacity-building resources and opportunities.

Virtual Library: Training resources on topics relevant to community foundations, including recordings, presentations, operations manuals, case studies, and research materials.

Internal Calendar: Includes events, committee meetings, and Comunalia program deadlines.

External Training Calendar: A curated list of training events offered by well-recognized organizations in the sector.

External Calls for Proposals: Whether for funding or training opportunities, these are shared via email or WhatsApp groups.

The members of the Alliance's community foundations actively participated in the Finance, Connections, Credibility, Continuity, and Capacity Committees. They met regularly, enriched our work, and guided Comunalía's decision-making and actions to fulfill our mission.

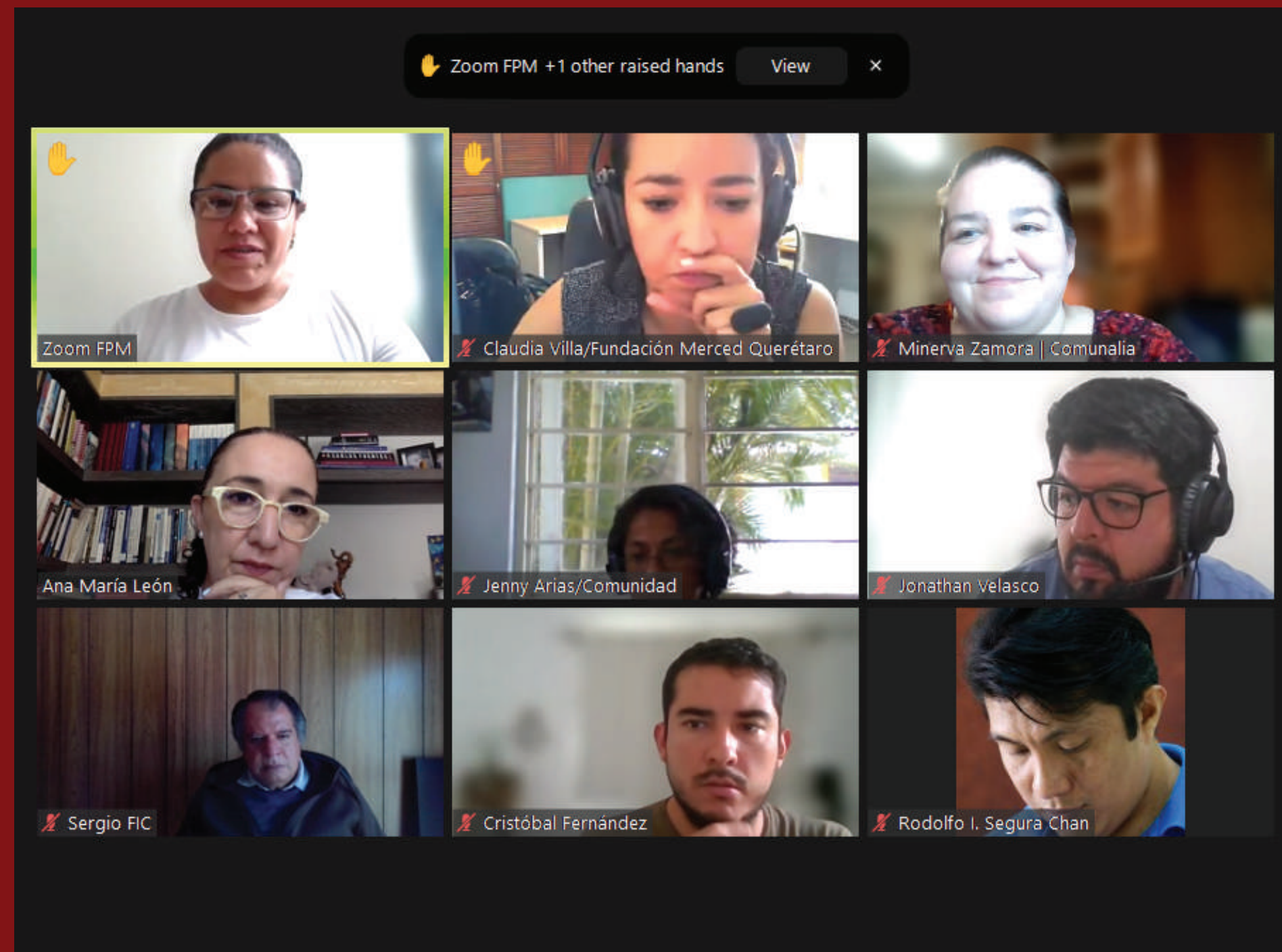

Individual Strengthening Giving Circles

In partnership with Philanthropy Together, we launched the Launchpad for Hosts program— a training and support process for community foundations to design, start, and strengthen **Giving Circles** in their territories.

We shared tools, methodologies, and experience to foster a culture of giving through strategies adapted to each foundation’s context, helping mobilize resources within their communities.

- 4 virtual workshops held
- 6 community foundations participated



4 community foundations received grants from Comunalia to launch their Giving Circles programs:



4 Giving Circles were activated through the community foundations, raising MX\$172,450, which was matched by Comunalia, **resulting in MX\$344,900** to support 6 community projects.

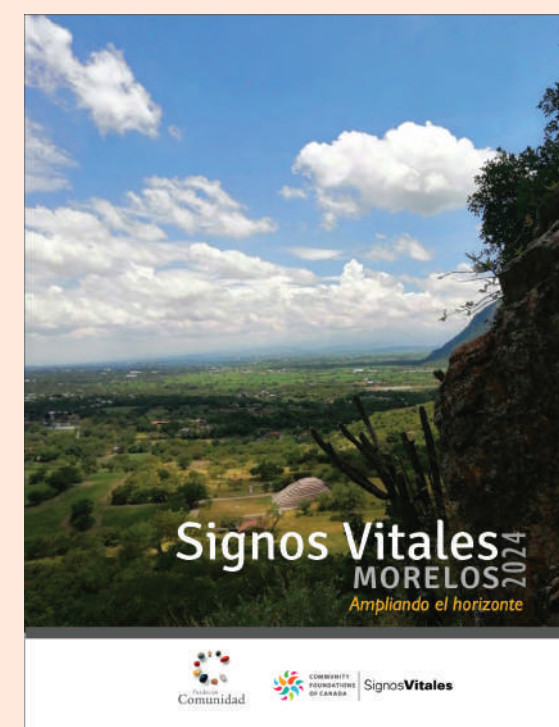

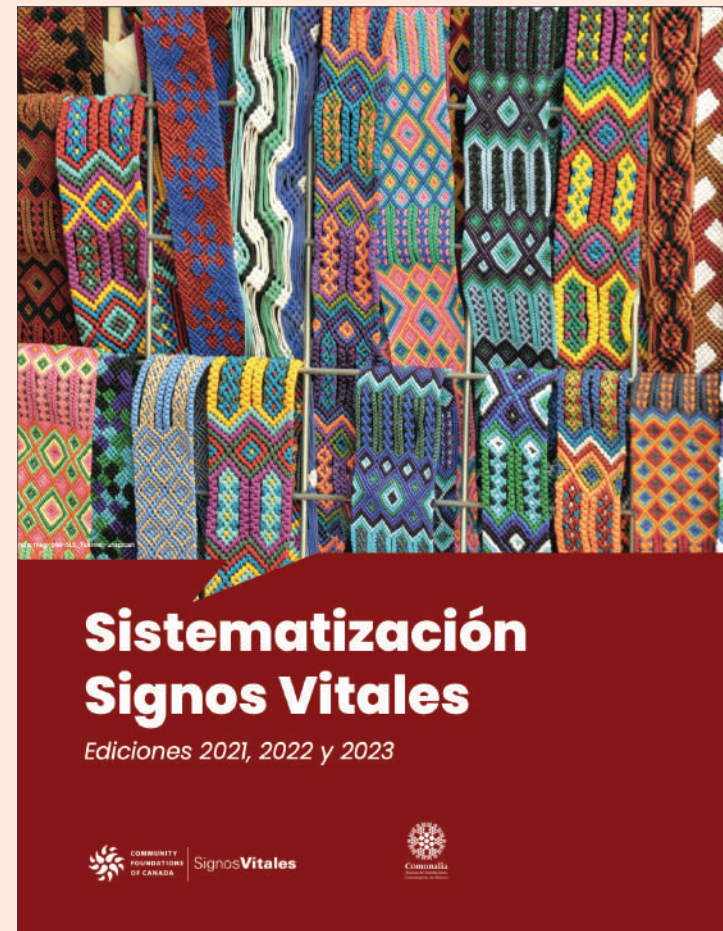

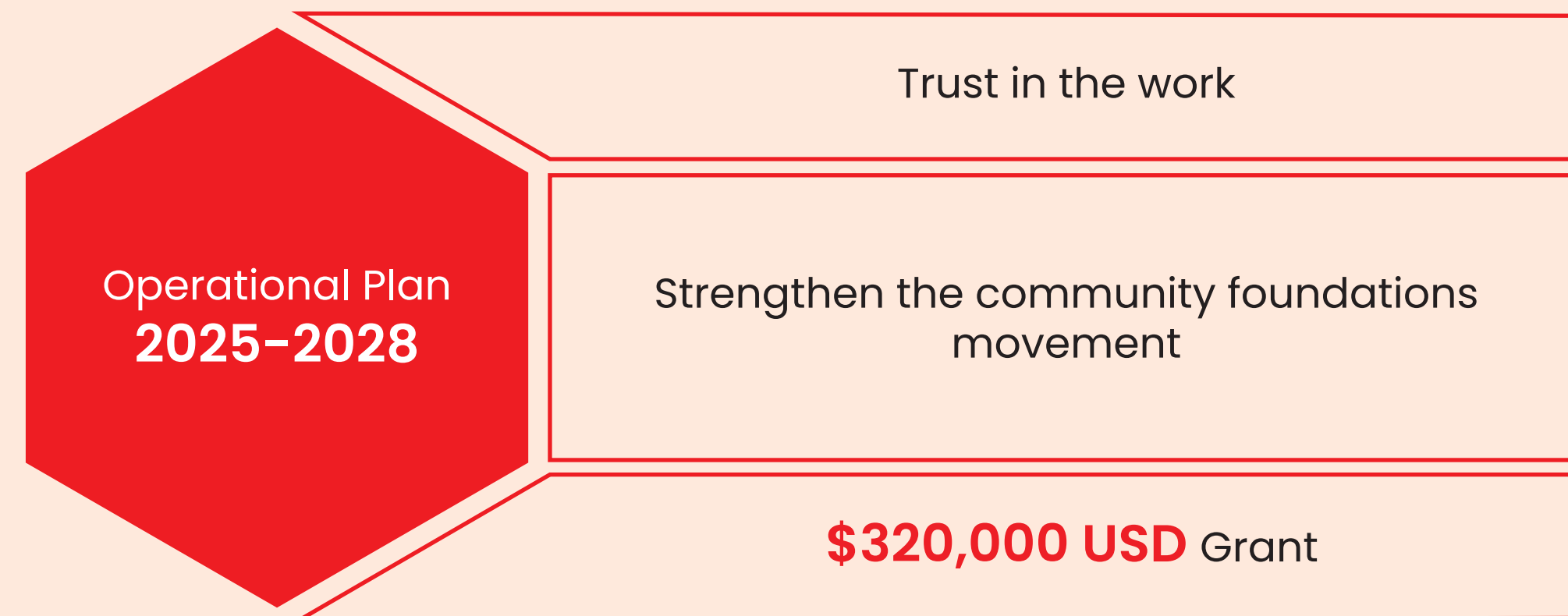

Signing of the new donation agreement with the Mott Foundation

We presented the 2025–2028 Operational Plan to the Charles Stewart Mott Foundation, aimed at strengthening the community foundations movement in Mexico with a strategic and sustainable vision.

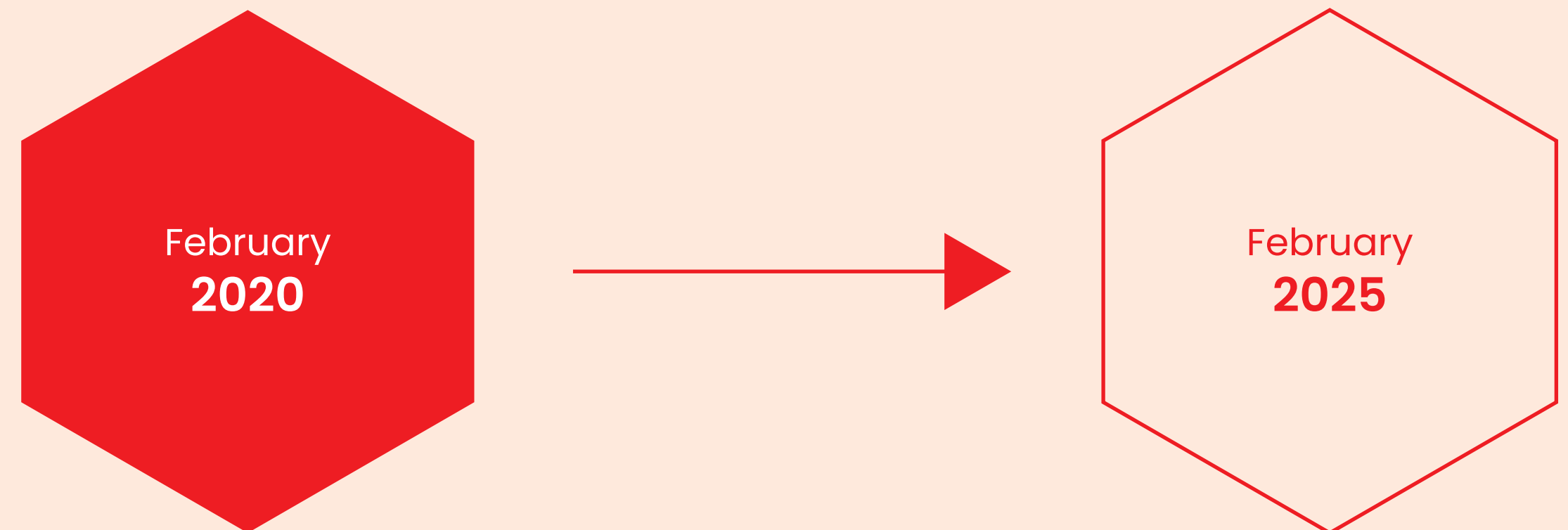
The Mott Foundation reaffirmed its confidence in Comunalía's work and results by approving a \$320,000 grant to support our consolidation phase.



Implementation of the final phase of the donation agreement with the Inter-American Foundation

In 2024, Comunalía continued implementing the objectives and activities established in the donation agreement with the Inter-American Foundation (IAF) for the period from February 2020 to February 2025. This support has been key to promoting community philanthropy in the territories where the foundations operate, strengthening their capacity for response and local sustainability.

Donation agreement term:



Community Actions Fund

We launched the call for the Community Actions Fund, with a budget of 600,000 MXN pesos, thanks to the support of MONEX Financial Group and the Mott Foundation. The purpose is to continue economic development projects led by our community foundations and their partners, promoting their sustainability and impact.

3 grassroots development-focused projects were selected:



Funding from #LiftUpPhilanthropy by the WINGS Foundation



In collaboration with CEMEFI and Alternativas y Capacidades, the Initiative for Climate Action in Mexican Philanthropy was presented, and funding was approved by #LiftUpPhilanthropy from the WINGS Foundation with a grant of €60,000 to be executed from November 2024 to October 2025. The project aims to mobilize the philanthropic sector in Mexico toward climate action by strengthening capacities, promoting best practices, and coordinating resources to advance community resilience projects.

Expand the community foundation movement

We implemented the diagnostic and identification phase to engage potential community foundation promoter groups, laying the groundwork for a future strategy to expand the movement.

This process, supported by LANZA S.C. and driven by the Mott Foundation, reached five groups interested in the community foundation model.

At Comunalia, we are convinced that strengthening the social fabric begins at the local level. That's why we will continue to promote the creation of new community foundations that transform their territories from within.

Comunalia on the Global Agenda: Philanthropy and Sustainable Development

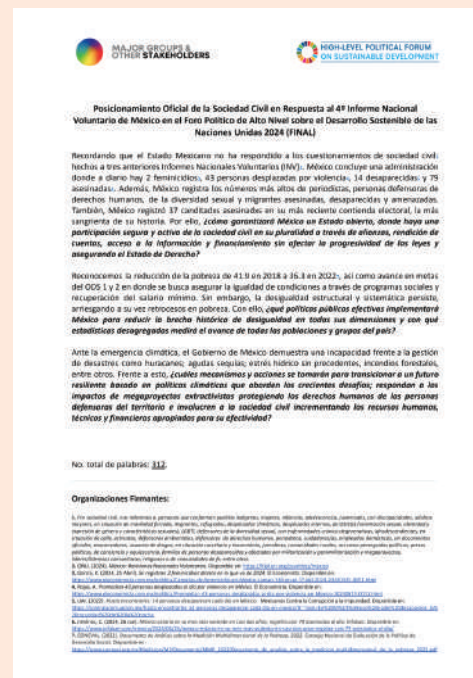
Comunalia joined the Steering Committee of Working **Group 9 of the C20** on Philanthropy and Sustainable Development, coordinated by **WINGS, GIF, and IIED**. The organization promoted the work of community foundations in Latin America and highlighted relevant initiatives such as the Active Communities Fund, Trust Research, MY World Jalisco, and the BCS Community Alliance. These initiatives were included in the recommendations submitted to the G20, emphasizing the impact of a community-based approach.

International Visibility of Local Impact

We contributed to the development of the official position of Mexican civil society before the UN as part of the **Fourth Voluntary National Review**, presented at the **High-Level Political Forum**. This effort strengthened the visibility and impact of community foundations in the local implementation of the SDGs.





Promoting Resilience and Sustainability

Comunalia, together with local organizations, participated in the **“Weaving Resilience”** gathering in La Paz, BCS, strengthening the focus on equity and sustainability to address environmental challenges in vulnerable communities.

Advancing Regional Strengthening of the Philanthropic Ecosystem

Comunalia took part in organizing the Third Meeting of the WINGS Latin America and Caribbean Working Group, held at Casa CEMEFI. The event brought **together 41 representatives from 30 organizations** to share strategies and collaborative experiences aimed at strengthening regional philanthropy.



Impact Minds 2024

Comunalia participated in and facilitated the attendance of community foundations at Latimpacto's Impact Minds 2024 event in Oaxaca. In this space, our partners connected with leaders from the social and business sectors, promoting innovative strategies.



Strategic Connections from Oaxaca

We participated in the networking event “Amigos y Amigas,” organized by Fundación Comunitaria Oaxaca, to strengthen alliances around community development.

This space fostered valuable connections between the community foundations in our network and organizations, businesses, and social actors.



CCA Meeting 2024

On behalf of the Alliance, Comunalía participated in the Connecting Communities in the Americas meeting in Dubuque, Iowa, where we moderated the panel on innovation and territorial work, highlighting the Mexican community foundation model.



The 2024 RedEAmérica International Forum

Within the framework of the RedEAmérica International Forum in Panama, we participated in the panel “Resilient Communities” alongside CEMEFI and Fundación Empresas Polar, where we invited Jennifer Arias from Fundación Comunidad to share the experience of the Comunidades Unidas en Resiliencia project.



Manifiesta Nodes Meeting: “Weaving Networks”

Together with Corporativa de Fundaciones, Fundación Merced Querétaro, FECHAC, and Fundación Comunitaria Oaxaca, we participated in the Manifiesta Nodes Meeting: “Weaving Networks,” a space to address the challenges and opportunities of civic space in Mexico.

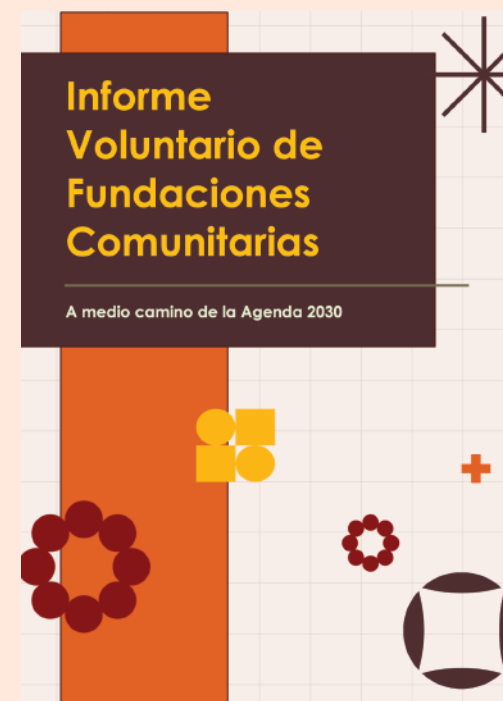
Initiative for Climate Action in Mexican Philanthropy

Together with Alternativas y Capacidades, CEMEFI, and WINGS, we convened and conducted working groups to identify strengths, opportunities, and actions to advance Mexican philanthropy in addressing climate change.

67 people from 21 civil society organizations, 6 companies, and 5 foundations participated and collaborated in the workshop.

Bringing Tools Closer to Act in Emergencies

We signed an agreement with the National Center for Support in Epidemiological Contingencies and Disasters, enabling foundations to access tools, training processes, and support networks that strengthen their capacity to respond to disasters in their communities.



Community Foundations Voluntary Report

Comunalia published the Voluntary Report of Community Foundations, developed in collaboration with the 17 foundations that make up the Alliance, aiming to highlight the reach and diversity of our movement.

As a member of the Advisory Council, Comunalía participated in the review of the report *Connecting Community Foundations with Family Philanthropy in Latin America: Mexico*, prepared by the Dorothy A. Johnson Center for Philanthropy with support from the Mott Foundation. The report identifies key opportunities to strengthen collaboration between community foundations and philanthropic families. We supported its dissemination through four events held in Guadalajara, Puebla, Mexico City, and NL.



Lightning Giving Circles

To promote new forms of community funding, Comunalía joined CEMEFI and HIPGive for the second year in activating a Lightning Giving Circle, raising a fund of 62,500 pesos delivered to 2 organizations focused on gender equity.

Building on this experience, we developed the Practical Guide in partnership with HipGive and Un Día Para Dar México, so that more groups and organizations can replicate this agile and participatory model.

Anti-Racism Learning Community Workshops

In collaboration with CEMEFI, we participated in 4 sessions of the Anti-Racism Learning Community, a space dedicated to strengthening collective reflection and promoting inclusive practices in the social sector. From this effort, we contributed to the development of the Guide to Adopting Anti-Racist Philanthropic Actions, a key tool.
